As a family-owned company we do not publish commercial figures. The respective country-specific legal requirements apply to the storage of documents. As a rule, this is usually 10 years. Our suppliers also have their own guidelines.

EMPLOYEE TRAINING

The continuous development of our employees is crucial to the success of our company. Dolder invests heavily in targeted training and development of our experts. Needs are discussed with employees at least annually and detailed training plans are developed.

LIABILITY

We have product liability insurance in the amount of CHF 10M with Helvetia Insurance.

RISK MANAGEMENT AND EMERGENCY PLANS

Our risk management is regularly reviewed and helps us to identify potential hazards and eliminate them through appropriate measures. Detailed contingency plans ensure that we can respond appropriately in the event of an incident.

SUPPLIER QUALIFICATION

We qualify our suppliers and are in constant contact with them to improve products and services. As a rule, we purchase our products directly from the manufacturer. This has been conscientiously checked by us to ensure that our high quality standards are met. The most important suppliers are regularly evaluated by us. Wherever available, we will issue a long-term supplier declaration.

WAREHOUSING AND TRANSPORT

We have an ERP system in which all purchasing and sales processes are mapped. The products supplied by us are transported and stored under the product-specific conditions. The responsible persons have the relevant information at their disposal. We apply Kanban and also offer consignment stock to our customers. Products are usually accompanied by certificates of analysis and safety data sheets. By arrangement, we offer to take back packaging material.

INSPECTION OF GOODS

Our suppliers take care of the quality control of the goods delivered to you. Our external warehouse and logistics partners do a visual inspection of the goods, provided they pass through our warehouse. We provide you with compliant certificates of analysis for each product, indicating the manufacturer and the testing body. We inform our customers immediately if there are any changes in the product or in the production process.

HANDLING OF NON-CONFORMING PARTS

We have a detailed 8D process in place for the rapid clearance of non-conforming parts and supplies.
